After a period of extensive engagement with our members, we are now very excited to launch a range of NEW resources – including a facilitator pack, child-friendly leaflets an video - to support babies, children and young people to get involved - either through a supportive organisation or independently. You can find these resources here. Our 2024 report will act as a baseline for our #RightsOnTrack campaign, to get a clear

picture of what life is really like for children as Scotland moves to inc UNCRC into law. This will help us measure impact and progress until the UK and Scotland are next reviewed by the UN (in approximately 2032). The deadline for submitting stories to Together is 19th July 2024
