ABOUT ROCK

The 'Rights of the Child UK' (ROCK) is a coalition of voluntary organisations and individuals working together to embed children's human rights into law, policy and practice.



Successive governments at a UK and devolved level have asserted their desire to become the best place in the world for children to grow up. The Rights of the Child UK coalition believes this can only be achieved by bringing the UN Convention on the Rights of the Child (UNCRC) into law, bringing the rights enshrined in the Convention within the reach of all children and young people, regardless of their background or circumstances.

Our aims are to:

- 1. Achieve the active recognition and realisation of children's rights in the UK jurisdictions and Jersey through the incorporation of the UNCRC into law at UK-wide and devolved levels.
- 2. Identify and act upon opportunities for the incorporation of the UNCRC into law;
- 3. Work together to maximise the opportunities to strengthen children's rights that are presented by proposals from the UK and devolved governments.

The ROCK steering group is made of up Together (Scottish Alliance for Children's Rights), Children's Rights Alliance England, Children's Law Centre, Children in Wales, Wales UNCRC Monitoring Group, and UNICEF UK.

The current chair is Juliet Harris, Director of Together (Scottish Alliance for Children's Rights).

Together

Together (Scottish Alliance for Children's Rights) is an alliance of Scottish children's charities that works to improve the awareness, understanding and implementation of the United Nations Convention on the Rights of the Child (UNCRC).



We do this by:

- Promoting the UN Convention on the Rights of the Child
- Helping children's organisations to integrate the UNCRC into their work
- Monitoring and reporting on the progress made at a Scottish and UK level

Our growing membership is made up of a range of children's charities, from small local playgroups through to large international charities, alongside individuals, academics and professionals with an interest in children's rights. Together consults widely with its membership through seminars, meetings and other ongoing communications.

Our activities

Some of the activities Together undertakes to improve awareness, understanding and implementation of the UNCRC include:

- Exploring children's experiences of their rights through participatory projects such as the Rights Detectives.
- Publishing an annual State of Children's Rights report to provide a nongovernment perspective on the extent to which children in Scotland are experiencing their rights enshrined in the UNCRC.
- Submitting consultation responses to the Scottish and UK Governments, to UN treaty bodies including the UN Committee on the Rights of the Child and to the UN Universal Periodic Review
- Publishing a fortnightly newsletter which highlights children's rights news from Scotland, the UK, and internationally as well as providing information on consultations and events.

Wales UNCRC Monitoring Group

The Wales UNCRC Monitoring Group is a national alliance of nongovernmental and academic agencies, tasked with monitoring and promoting the United Nations Convention on the Rights of the Child in Wales. The UNCRC Monitoring Group was established in 2002 and since May 2016 has

been facilitated by Children in Wales. The Group has worked with the UN Committee on the Rights of the Child and submitted successive civil society reports to inform UK State Party examinations.

The aims of the UNCRC Monitoring Group include to:

- Work together to ensure the effective co-ordination of monitoring of the UNCRC in Wales, including through producing Civil Society shadow reports.
- Monitor the implementation of the UNCRC in Wales.
- Promote the UNCRC, the UN Concluding Observations and recommendations of the Monitoring Group civil report to the UN.
- Work to ensure arrangements are in place for the effective reporting to the United Nations Committee on the Rights of the Child through collaboration between the Welsh Government, children, young people and NGOs working together in this process.
- Promote the participation of children in monitoring and reporting activities.
- Identify opportunities for influencing Welsh and UK Government on implementation of the UNCRC.
- Promote public awareness, particularly of children and young people about the UNCRC.
- Ensure Wales is represented at Wales and UK wide forums and events relating to the UNCRC.

Members of the Monitoring Group include Children in Wales, Barnardo's Cymru, Children's Legal Centre Wales, National Deaf Children's Society Wales, NSPCC Wales, Play Wales, Save the Children Wales, UNICEF, Wales Observatory on Human Rights of Children and Young People, Children's Commissioner for Wales (observers), Welsh Local Government Association (observers) and the Equality and Human Rights Commission in Wales (observers).

Juliet Harris

Director, Together (Scottish Alliance for Children's Rights)



Juliet is Director of Together (Scottish Alliance for Children's Rights). Over the past decade, Juliet has led work to progress the human rights of children across legislation, policy and practice.

She is Vice Chair of the Children's Parliament, a Trustee of the Environmental Rights Centre Scotland and is a founder member of the Observatory of Children's Human Rights Scotland. She sits on numerous Scottish Government Advisory Groups, including the UNCRC Strategic Implementation Board and the Human Rights Bill Advisory Board. She is the Chair of the Rights of the Child UK Coalition (ROCK) and has played an active role on a number of UN Taskforces,

including UN Committee's Day of General Discussion on Children as Human Rights Defenders.

Juliet is a guest lecturer at the University of Edinburgh and her work on children's rights has been published widely.

Hanna Borg Jónsdóttir

Child Rights Specialist and Programme Director, UNICEF Iceland

Hanna Borg Jónsdóttir, born in Hafnarfjordur, Iceland, is an accomplished lawyer and expert in child rights. She holds a Magister Juris degree from the University of Iceland (2012) and an LLM in Human Rights from Queen Mary University of London (2017), where she specialised in children's rights. With extensive experience in the field, she has worked for the Ministry of Foreign Affairs and currently serves as the Programme Director for Child Friendly Cities at UNICEF Iceland, a role she has held since 2020.



In her work at UNICEF, Hanna collaborates closely with 23 municipalities around the country that are currently working on becoming a recognised Child Friendly City. Her work also involves working with the Ministry of Education and Children and she is an active member of various working groups focused on developing action plans for implementing the United Nations Convention on the Rights of the Child (UNCRC) in Iceland. She is also the author of *Rúnar góði* (2016), a popular children's book that introduces young readers to the UNCRC and promotes children's rights. The book, which is widely used in primary schools, has also become a favorite for parents and children to read together. In addition to her writing, Hanna develops educational materials aimed at fostering child rights education.

Outside of her professional career, Hanna enjoys football, dancing, hiking, and singing, particularly with her family—her husband and three children, two boys and a girl.

Nicola Killean

Children and Young People's Commissioner Scotland

Nicola Killean is the Children and Young People's Commissioner Scotland. She and her team are responsible for protecting and promoting the human rights of everyone under 18 in Scotland, or up to the age of 21 if they have care experience.



Nicola has spent most of her career

supporting children and young people from communities facing particular challenges and disadvantages. Nicola was founding Chief Executive Officer of the charity, Sistema Scotland. She oversaw the launch and growth of the charity which delivers Big Noise programs, using music and nurturing relationships to support over 3,500 children and young people across Scotland.

Nicola was awarded an OBE in 2020 for services to music, children and community cohesion.

Who am I?

I live in South Wales with my young son. My background is as a family and childcare solicitor; starting out in high-street private practice in the south of England representing parents, then returning home to work for a Welsh local authority on care proceedings and adoption cases. I'm a Welsh speaker, and I enjoy walks, baking and playing the piano to relax.

What do I do?

I am Head of Policy and Public Affairs for the Children's Commissioner for Wales (CCfW). I've worked for CCfW since 2015, starting as a Policy Advisor on Social Services, Communities and Justice. I led the office's projects on children's experiences of residential care in Wales, which produced a report entitled The Right Care, and support for care leavers during their transition to adulthood, resulting in the Hidden Ambitions report. I also led on the formal review of WG around home education and independent schools policy in 2021.

Natalie Don-Innes MSP is the Minister for Children, Young People and Keeping The Promise within Scottish Government.

Natalie Don-Innes was born in Paisley and grew up in Bridge of Weir. She attended Gryffe High School and then went on to study History at University of Glasgow.

Before and during her time at University, Natalie worked in a variety of sales roles working her way up to Manager of a local food retailer.

Natalie was elected as the Member of the Scottish Parliament for Renfrewshire North and West in 2021. Prior to this, she served as the Councillor for Bishopton, Bridge of Weir and Langbank.

Louise King

Director, Children's Rights Alliance for England, and Co-Lead, Just for Kids Law

Louise has over 20 years' experience working in policy and public affairs, specialising in children's rights. She rejoined the Children's Rights Alliance for England (CRAE) as its Director in March 2015 (having previously been its Senior Policy Officer)



and oversaw its merger into Just for Kids Law, a charity providing legal advice and representation to children and young people. In August 2023, she became Co-Lead of Just for Kids Law with Aika Stephenson, the charity's Legal Director.

As well as Co-Leading Just for Kids Law, Louise is responsible for the organisation's thematic policy and public affairs strategy, which focusses on children's rights in the justice system, as well as leading CRAE's broader children's rights monitoring and advocacy work. As part of this broader work, she Co-Chairs the UNCRC Action Group with a senior civil servant at the Department for Education. Louise is also a former Chair of ROCK (Rights of the Child UK).

Prior to joining CRAE, Louise worked at Save the Children. Most recently, she led on child rights governance policy and advocacy in the UK. She has also been Vice President of Euronet - the European Children's Network, and Chair of the Separated Children in Europe Programme.

After graduating in philosophy and theology from the University of Nottingham, Louise volunteered for the British Youth Council before taking up the position of Policy Officer where she led on campaigns to lower the voting age to 16 and for the establishment of a Children's Commissioner for England. She then joined CRAE as Senior Policy Officer before joining Save the Children, where she first worked on policy issues relating to child victims of trafficking and children seeking asylum.

Louise has facilitated numerous participatory workshops for children to learn about their rights and empowered children and young people to advocate for the realisation of their own rights across many policy areas including protection from violence, school exclusion, housing and homelessness, and immigration.

Paddy Kelly

Centre Director, Children's Law Centre



Paddy Kelly is a Barrister; she holds an LLB and LLM in Human Rights Law from Queen's University, Belfast. In 1997 Paddy established the Children's Law Centre as the leading children's rights NGO in Northern Ireland. CLC uses the law to vindicate children's rights through litigation, policy and legislative engagement, training and promoting the voice of the child.

After practising as a Barrister, Paddy worked for a number of years with voluntary sector organisations

including Save the Children. She established CLC after the first examination of the UK government by the UN Committee on the Rights of the Child. She has led the NGO sector in this jurisdiction in reporting to the UN Committee on the Rights of the Child for each of the UK's examinations to date, having also attended each examination. Paddy has ensured the attendance of young people from Northern Ireland at the 2002, 2008, 2016 and 2023 examinations. CLC coordinated, compiled and edited a series of submissions on behalf of the sector during the most recent examination of the UK by the Committee.

Paddy was appointed to the first NI Human Rights Commission (NIHRC) established under the Good Friday Agreement. Paddy has worked to deliver the children's rights protections provided for under the Good Friday Agreement, including those at risk as a result of Brexit. She has been active in working to secure a Bill of Rights for Northern Ireland, to include strong children's rights protections, as provided for in the Good Friday Agreement.

Paddy is currently a member of the Safeguarding Board for Northern Ireland and also serves as a Commissioner on the Charity Commission for Northern Ireland.

Sean O'Neill

Policy Director, Children in Wales & Wales UNCRC Monitoring Group

Sean is the Policy Director and Deputy CEO at Children in Wales with over 20 years of knowledge and experience in the children's sector. His principal areas of policy interest include child poverty, children's rights, addressing disadvantage and issues pertaining to care experienced children. Sean manages a number of professional networks and is currently Chair of the End Child Poverty Network



Cymru and the Wales UNCRC Monitoring Group. He was part of the delegation which represented Wales civil society sector at the UN pre-sessional and state party hearings in Geneva in 2016 and 2023 and has spoken extensively at local, national and international conferences and events on children's rights matters.

Sean is a passionate activist for children's rights and continues to campaign and advocate on behalf of children's issues in a variety of national strategic forums in Wales, including Ministerial advisory groups and is a former Management Board member of Eurochild. Sean has a background in research, experience of front-line housing and advocacy services and has a publication record.

UNICEF is mandated by the UN General Assembly to work together with national governments and support them in realisation of children's rights. Article 45 of the Convention entitles UNICEF to be represented at the consideration of the implementation of the Convention.
